1. The securities awarded on 1/23/2015 were in the form of stock options issued pursuant to the Sage Therapeutics, Inc. 2014 Stock Option and Incentive Plan. Options to purchase 4,375 shares of common stock vested on the one year anniversary of the Vesting Start Date with 13,125 shares vesting in 36 equal monthly installments thereafter. Options to purchase 42,000 shares of common stock vest periodically over four years from the grant date upon the company reaching certain milestone requirements, of which the performance criteria were met with the respect of 12,600 shares.
